



Research Fellowship at Centro de Investigação do Instituto Português de Oncologia do Porto (CI-IPOP)

CI-IPOP, hosted at Instituto Português de Oncologia do Porto Francisco Gentil, EPE, invites applications for 1 (one) research position (BI) for a BSc or MSc, for working as *Data Manager* on the project ***“Impact assessment of the implementation of a new organizational model at Outcomes Research Lab”*** (CI-IPOP 132-2019).

Scientific Requirements and objectives: We are looking for highly motivated and enthusiastic candidate holding a bachelor or master degree in Biomedical Engineering, Economics, Management, Health and Life Sciences or equivalent (mandatory). Experience in data collection from clinical charts and knowledge of medical terminology, spreadsheet software (Excel), statistical packages software (SPSS, R or STATA) and *Power BI* will be valued. Former participation in healthcare research activities is a plus. Fluency in written and spoken Portuguese (mandatory) and English. It is mandatory to be registered in a specialization course, practical course or continuing education course in the oncology area (not awarding an academic degree). It is possible to present a declaration of honor at the application stage, and the proof of registration must be carried out until contracting.

Duration and stipend amount: The position is for a period of 1 year, eventually renewable for the same period. Salary will be according to the Portuguese Science Foundation pay scale within the country, 835.98€ per month for a BSc or 1104.64€ per month for a MSc research fellowship (BI).

Funding of the grant: Project *“Impact assessment of the implementation of a new organizational model at Outcomes Research Lab”* (CI-IPOP 132-2019).

Applicable law and regulations: Law 40/2004 of August 18 (“Estatuto do Bolseiro de Investigação Científica”), altered by Law 950/2019 of December 16 and Law 643/2021 of July 14.

Application period: from 24/01/2022 until 08/02/2022 (8 p.m.).

Methods of selection: Candidates will be pre-selected based on their Curriculum Vitae and Letter of Motivation. An interview might be applicable.
